

Guidelines when Viewing Vessels

We want to ensure that you have the very best experience possible when viewing one of our vessels. As such we take all aspects of safety very seriously.

Overview

To ensure your safety whilst viewing a vessel, please be aware of the location of the following sites in the marina or yard: Emergency Points – with life rings and safety advice, Fire Assembly Points, Water Evacuation Points, Emergency Boxes – with fire extinguishers, throw lines, first-aid kits and thermal blankets. In an emergency dial 999 and select the service you require. Tell the operator the nature of the emergency, where you are and your telephone number; then call the Marina or Yard Reception.







General Safety Advice

- Please wear non-slip, non-marking footwear without heels that is appropriate for
 the expected weather conditions. We would be grateful if outer footwear is
 removed on entering the cabin of the vessel; please be careful not to trip, slip or
 crush your feet.
- Please wear appropriate clothing for the expected weather conditions including eye protection, especially in bright sunlight.
- Please wear any additional personal protective equipment as may be reasonably expected or as requested during your viewing.
- All vulnerable persons aboard must wear a lifejacket on the flybridge, foredeck, main deck, side decks and bathing platform if the vessel is afloat and not undertaking a passage. All persons must not be alone in any circumstances in these areas after dark.
- All vulnerable individuals accompanying, or acting for or on behalf of us, if they are
 to pass within 5m of the water's edge, including but not exclusive to pontoons,
 jetties, quays and wharfs, must wear lifejackets.
- Any individual must wear a life jacket within 5m of the water's edge if requested to do so



- Children should be supervised at all times. Please do not bring pets and / or animals
- Please do not eat, drink, or smoke aboard any vessel, tender or small craft. Do not smoke or use a mobile telephone on or near the marina's fuel pontoon, materials storage areas, or rubbish compounds.
- Being under the influence of or using alcohol or drugs as defined by the Railways and Transport Safety Act 2003 on our vessels is strictly prohibited. Anyone giving the Directors cause for concern may be summarily breathalysed and/or tested for drugs.
- In wet or icy weather please be careful regarding all potentially slippery surfaces.
- At all times be extremely careful when accessing areas that are thin or unguarded;
 for example, passerelles, boarding ladders and planks, bridges, etc.
- It is strictly forbidden to swim, fish or scuba dive in the marina.



- Do not use bicycles, scooters or skateboards on the pontoons or jetties.
- Do not ride, or allow children to ride, in the marina or yard trolleys.
- Do not sail or row boats in the marina.
- Do not remove supports, leads or pipes from vessels in the marina or yard.
- Keep clear of vessels and machinery involved in lifting operations.
- First aid is available from the marina or yard reception 24 hours a day.
- Locate and familiarise yourself with the positions of the marina or yard safety
 boxes you will find them on the pontoons. Nearby you will find emergency ladders.
- Use rescue equipment only in the event of an emergency advise the marina or yard reception if you use any of the equipment. Misuse of this equipment may have life-threatening ramifications for future users.
- Report all accidents and potential hazards to the marina or yard reception immediately.





In An Emergency

- Do not try to tackle the incident yourself unless you are appropriately trained for the incident at hand and it is safe to do so.
- In the event of an evacuation leave immediately and head for the nearest Fire Assembly Point. If the route is blocked, make your way to the nearest Water Evacuation Point.
- Follow all instructions given by us, marina or yard staff, security and the emergency services.
